

Data Protection Policy of CELESTIA ESCAN S.L.

1. Who is the Data Controller of your data?

The Data Controller of the data processing referring to the different processes regarding the management of users, clients and potential clients, collaborators and suppliers is **CELESTIA ESCAN S.L.** with registered office in C/ Practicante Ignacio Rodriguez S/N, Edificio Po, 35017 Las Palmas De Gran Canaria (Las Palmas) and VAT Number B76198001.

2. What kind of data do we have about you and how have we obtained them?

The categories of personal data that is **CELESTIA ESCAN S.L.**, deals with about its users are:

- Identification personal data
- Postal or electronic email, telephone contact number
- Commercial information
- Economic and transaction data
- In no case do we treat specially protected data.

All the aforementioned data we have obtained or directly from you through the presentation of a commercial offer, contractual proposal, etc. or through your company to provide us with identification data and other information necessary to carry out the purpose of the contractual relationship between the parties. It will be an obligation of yours or your company to provide us with the updated data in case of modification.

3. For what purpose do we process your data?

In **CELESTIA ESCAN S.L.** we deal with the data provided by interested persons in order to manage different activities derived from specific procedures carried out in sales, after sales service, supplier management, quality of services, etc. In this way, we will use your data to carry out some of the following actions:

- Sending the information requested by the contact form on our website or any other means of contact with our company,
- Facilitate both potential customers and our customers, offers of products and services of interest,
- Carry out the administrative, fiscal and accounting management of our clients and / or suppliers,
- Carry out satisfaction surveys, market studies, etc. in order to be able to offer you the most suitable offers and an optimized service quality, etc.

We will not elaborate commercial profiles based on the information provided and consequently we will not make automated decisions about you based on a commercial profile.

4. How long will we keep your data?

The personal data related to individuals linked to potential customers, customers and suppliers that **CELESTIA ESCAN S.L.** collects through the different contact and / or information collection forms will be kept as long as the deletion is not requested by the interested party. The personal data provided by our customers and suppliers will be kept while the commercial relationship between the parties is maintained, respecting in all cases the minimum legal terms of conservation according to the matter.

In any case, **CELESTIA ESCAN S.L.** will keep your personal data for a period of time that is reasonably necessary, taking into account our needs to respond to issues that arise or solve problems, make improvements, activate new services and meet the requirements required

by applicable law. This means that we can keep your personal data for a reasonable period of time even after you have stopped using our products or have stopped using this website. After this period, your personal data will be deleted from all systems of **CELESTIA ESCAN S.L.**

5. What is the legal basis for processing your data?

According to the type of data processing, we summarize in the following the basis of legitimization of said treatment:

Regarding legal basis mentioned above,, you are obliged to provide personal data, in the event that you do not provide your personal data, your contract can not be executed or comply with legal obligations or derived from official authority.

6. What are your rights as affected or interested person?

CELESTIA ESCAN S.L. will never share your personal data with any third parties that intends to use them in their direct marketing actions, except in the case that you have expressly authorized us to do so.

We inform you that we can provide your personal data to Public Administration bodies and competent authorities in those cases that **CELESTIA ESCAN S.L.** receives a legal requirement by said Authorities or in cases that acting in good faith, we consider that such action is reasonably necessary to comply with a court process; to answer any claim or legal claim; or to protect the rights of **CELESTIA ESCAN S.L.** or its customers and the general public.

CELESTIA ESCAN S.L. can provide your personal data to third parties (for example, Internet service providers that help us manage our website or carry out the contracted services, support companies and IT maintenance, logistics companies, agencies and tax and accounting advice, etc.). In any case, these third parties must maintain, at all times, the same levels of security as **CELESTIA ESCAN S.L.** in relation to your personal data and, when necessary, are bound by legal commitments in order to keep your personal data private and secure, and in order to use only the information following specific instructions from **CELESTIA ESCAN S.L.**

7. What are your rights as affected or interested person?

Anyone has the right to obtain confirmation on whether **CELESTIA ESCAN S.L.** is processing personal data concerning him/her, or not.

In particular, data subjects can request the right of access to their personal data, as well as receive them in a structured, commonly used and machine-readable format (Right to data portability).

Likewise, data subjects may request the right to rectify inaccurate data or, if appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes that were collected.

In addition, in certain circumstances, the data subjects may request the limitation of the processing of their data, or in certain circumstances and for reasons related to their particular situation, data subjects may exercise their right to object their personal data. **CELESTIA ESCAN S.L.** will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of possible claims or in those exceptions established in the applicable regulations.

Likewise, we inform you that you have the right to erasure the given consents at any time, without affecting the legality of the processing based on the prior consent to its withdrawal.

Likewise, the User is informed that at any time he / she can exercise the aforementioned rights by writing to us using the contact data that appear in Section 1, 'Data Controller' of the present Personal Data Protection Policy **CELESTIA ESCAN S.L.** attaching a copy of a personal identification document. You will also have the right to bring and action before the Spanish Data Protection Agency, especially when you have not obtained satisfaction in the exercise of your rights.

9.1. Security measures

CELESTIA ESCAN S.L. adopts the security levels required by the European and Spanish regulations in force in data protection taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of processing, as well as the risks of varying likelihood and severity for rights and freedoms of natural persons posed by the processing.

9.2. Data processing of minors
